# A. MPA Activity

Chief Bade reported discussions with personnel from Alma and St. Louis, Michigan that are looking at the Metro model to form an Authority for their departments.

Chief Bade turned the meeting over to Officer Ryan Ortiz. Officer Ortiz said he and Officer Abraham held Camp 911 this year from June 23 through June 26, and that they had about 35 campers from grades 3 – 5. Officer Ortiz reported that they had presentations by 911, GHOST, MedStar, Paramedics, Catholic Charities, and the Mundy Fire Department. Officer Ortiz said that the Swartz Creek Kiwanis Club provided snacks and lunches as well as the Dragon Diner. The Board thanked Officer Ortiz for the success of Camp 911, and Chief Bade said Officer Ortiz and Officer Abraham do a wonderful job.

Chief Bade reported to the Board regarding an issue with insurance coverage for an officer assigned to FANG. Chief Bade described the issues to the Board as well as his discussion with the labor attorney. Board discussion.

Chief Bade turned the meeting over to Lt. Murphy who reported on OHSP, and the additional funds from the State given to Genesee County for OHSP. Lt. Murphy said that FANG helped tremendously with Hometown Days, and wants to use them for other investigations.
