#### **MINUTES**

David Krueger presented the Minutes from the August 23, 2023, meeting and asked for a motion. Tonya Ketzler made a motion to accept the minutes; Rae Lynn Hicks seconded the motion. Chad Young announced the Metro CIA luncheon being held today. Chad Young also reported that approvals were received at the Mundy Township Board meeting and he received word about the grant to make the expansion of Taylor Drive a reality which will take place over the next 18 months.

Tonya Ketzler announced that the PDP papers were signed yesterday with Costco, and will be going before the planning commission in October. Tonya Ketzler said that she was at a function Saturday, and 2 people from LaFontaine thanked her for buying the new Metro vehicles from them.
