#### MINUTES

Swartz Creek Manager, Adam Zettel addressed the Board about the anti-tax movement to abandon property taxes.

# III. BOARD MEMBER COMMENT

Nate Henry said he had a resident asking about traffic enforcement on Ingalls. Chief Bade indicated that Metro has devoted many hours to Ingalls Drive, and no citations have been issued.

Tonya Ketzler reminded everyone that Wednesday, May 15<sup>th</sup> is Police Memorial Day.

Cory Bostwick announced that February 17 – 25, the Township has early voting and a late night on Thursday night.

Cory Bostwick asked what was happening with Hometown Days. Lt. Murphy said that tentatively it will be held on Kincaid Field, and no rides will be on the streets. Chief Bade indicated there are a lot of changes based on their recommendations. Lt. Murphy indicated that the parade will still take place. Chief Bade said that Metro required access control.
